Legislative update

The Illinois Municipal League prioritizes protecting municipal revenues and sustainable local budgets

The General Assembly convened the 2018 legislative session on January 30, 2018. Governor Bruce Rauner delivered his fourth State of the State address to a joint session of the General Assembly the following day.

Legislative activity is usually subdued during the second year of a two-year legislative cycle as lawmakers facing re-election become more cautious and focused on their election campaigns. This year is no exception, with legislators returning to their districts for most of March and not returning until the second week of April. The absence of legislators during what is typically an active month

Also in this issue

during the legislative year significantly reduces the number of session days before a key April deadline for advancing bills out of committees in their chambers of origin. This dearth of session days means far fewer bills are likely to advance through the legislative process compared to last year.

The Illinois Municipal League (IML) is advocating to protect municipal revenues and reduce municipal cost-drivers. IML's legislative activities are focused on playing both offense and defense to accomplish these aims.

Legislative update from the IML

Several of the 15 legislative initiatives approved by the IML Board of Directors and presented to legislators are targeted toward enhancing or protecting municipal revenues. The IML initiatives summarized below should be of interest to municipal finance officers.

HB 4101 (Rep. DeLuca, D-Chicago Heights) and **SB 2249** (Sen. Hastings, D-Tinley Park) would roll back the 2% state administrative fee on locally-imposed sales taxes enacted as part of the State Fiscal Year (SFY) 2018 state budget. If approved, the bill would reduce the administrative fee to 1% and return an estimated \$30 million to local governments.

HB 4532 (Rep. Moylan, D-Des Plaines), HB 4584 (Rep. McCombie, R-Savanna) and SB 2645 (Sen. Bertino-Tarrant, D-Plainfield) would make several funds collected by the state on behalf of local governments subject to continuing appropriation. These funds include Motor Fuel Tax (MFT), video/casino gaming, Use Tax and 9-1-1 revenues. If approved, these critical funds would be released without the need for annual budget enactments.

HB 4365 (Rep. Fortner, R-West Chicago) would make municipalities providing utility services to state facilities eligible for interest payments on overdue utility payments in the same manner as private sector service providers. The interest payments would provide an incentive for prompt payment of municipal utility bills by the state.

SB 2336 (Sen. McConnaughay, R-St. Charles) would create due process rights for municipalities contesting property tax challenges in circuit court that would reduce the Equalized Assessed Value (EAV) of individual properties by \$100,000 or more. Municipalities would be provided a right to intervene in the circuit court to present evidence that could uphold the assessed value of property.

HB 4680 (Rep. Welch, D-Westchester) would close a tax loophole that prevents non-home rule municipalities from imposing a use tax on out-of-state natural gas providers. If approved, non-home rule municipalities would have the same authority to impose this tax as their home rule counterparts.

In addition to these IML legislative agenda bills, IML supports legislation to create a Marketplace Fairness Act in Illinois so that sales taxes owed from online purchases can be collected.

SB 2577 (Sen. Castro, D-Elgin) would establish a mechanism to collect sales taxes from online purchases should the United States Supreme Court decide in favor of South Dakota in the case of *South Dakota vs. Wayfair*. This important case is scheduled to be heard in April. SB 2577 was approved by the Senate Revenue Committee and will next be considered by the full Senate.

While pursuing a proactive and aggressive legislative agenda, IML is also working against efforts to reduce local revenues.

In his February Budget Address, Governor Rauner proposed to continue the 10% reduction in Local Government Distributive Fund (LGDF) payments enacted as part of the SFY2018 state budget. IML opposes the extension of this cut into SFY2019 and is already advocating for a restoration of LGDF distributions to the amount received by cities and counties prior to the SFY2018 reduction.

Over the last several years, Corporate Personal Property Replacement Tax (CPPRT) revenue has been diverted away from local governments to fund various obligations of the state. In January, IML provided testimony against **SB 2260** (Sen. Tracy, R-Quincy), which proposes to divert up to \$4 million from local governments in order to reallocate the money to fund schools. The bill was passed out of the committee and, as of this writing, was awaiting a vote by the full Senate. IML will continue to oppose this bill and any other proposed CPPRT diversions.

IML is committed to opposing any emergent property tax freeze legislation that would impact local revenues. No significant property tax legislation is advancing at present, but IML will continue to watch for and oppose property tax freeze bills throughout the 2018 legislative session.

IML is pursuing legislation to limit financial

obligations that stress municipal budgets.

Public safety pension fund consolidation would achieve this objective by creating administrative efficiencies and the prospect of higher investment returns as a result of expanded investment authority. Sen. Althoff (R-McHenry) introduced five IML-drafted bills that present various options for full or partial consolidation. These bills are: **SB 3422, SB 3423, SB 3424, SB 3425** and **SB 3426**. IML is pursuing a cost study of these bills by the independent Commission on Government Forecasting and Accountability (COGFA).

IML remains involved in working to advance legislation that allows municipal governments to continue filing annual audit statements with the Comptroller's Office using cash basis accounting standards. **HB 4104** (Rep. DeLuca, D-Chicago Heights) and **SB 2258** (Sen. Righter, R-Mattoon) would preserve the ability to file annual audit statements on a cash basis. Cash basis accounting statements are presently permissible under Illinois statute and are less expensive for municipalities than the more complicated and, in many cases, unnecessary accrual based accounting statements.

Municipal revenues continue to be at risk as long as the state is experiencing budget challenges and imposing new unfunded mandates. IML remains committed to advocating against revenue reductions/cost increases and is actively supporting legislative measures that facilitate sustainable municipal budgets and appropriately funded local priorities.

Automation: Bringing local governments into the 21st Century

Remember the first time you used a personal computer, or saw an ad for a smartphone? If you're like most of us, you were immediately dismissive. "Why would I need that? Why would anyone need that?"

Today, computers and smartphone are ubiquitous – helping us connect throughout the day, at work and at home, on the road and even in the air. Technology provides new ways of doing business, and automation helps everyone in the workplace do more with less. Over time, today's dismissive attitude becomes tomorrow's normal, even necessary.

It will take time, vigilance and reassurance every time a data breach hits the news, but you will earn their trust.

Regardless of the benefits, some will be adamantly opposed to automation. You can hold automation workshops and public meetings to walk them through each step of the process, providing detailed explanations. The more assurance you can provide upfront that you've planned for the worst-case scenario, the more persuasive you will be that automation is the best path forward in your community.

Automation works: in our daily lives, at home, and in the workplace. Every day, new technology is developed to make workflows easier, more reliable, and less consuming of our valuable time and resources. With the right partner and the right software, automation could be the best hiring decision you've ever made.
