Graduate and undergraduate students (including high school seniors/incoming freshman) formally accepted in an accredited community college or 4-year college/university in a full-time curriculum or for full-time employees, a part-time curriculum that will result in an associate, bachelor's or master's degree in accountancy, finance, or any business-related degrees as well as MBA and MPA degrees.
