Session 1: Employment Law & Workers Compensation: New Developments and Ongoing Concerns

Speakers: Robert T. McCabe, Of Counsel Ancel & Glink Britt Islay, Partner Ancel & Glink

Ancel Glink attorneys Robert T. McCabe and Britt Isaly will present a timely discussion of recent developments in their respective areas of practice, labor and employment law and workers compensation law. Also, both attorneys will provide an overview of issues that may be of concern to government finance professionals.

- Understand the implications of the recent U.S. Supreme Court decision regarding union fair share fees;
- Understand the importance of distinguishing between exempt and non-exempt employees;
- Understand recent issues and developments in the law of sexual harassment in the workplace;
- Understand the relationships between workers compensation, the American's with Disabilities Act (ADA), the Family Medical Leave Act (FMLA) and unpaid leaves of absence; and,
- Obtain a basic overview and understanding of the worker's compensation process from the initial filing of claims to completion of the case.

Session 2: Cyber Security: Best Practices for Protecting Benefit Plan Data

Speakers: Jeff Strachota, Manager of Security & Compliance, Sikich LLP Kara Hamstra, Director – Public Relations, Sikich LLP

The sensitive data associated with benefits plans, including protected health information (PHI), personally identifiable information (PII) and retirement plan data, is often the target of malicious actors. This session will discuss specific strategies to minimize the risk to sensitive data as part of a cyber-risk management plan. This session will also provide both useful information related to implementing best-practice security controls within your organizations and guidance on evaluating the cybersecurity programs of benefit plan service providers and preparing a communications plan in the event of a data breach.

Learning Objectives: Participants completing this session will be able to:

- Evaluate best practices for minimizing risk to sensitive and/or critical data;
- Understand the different threats to benefit plan data;
- Begin the process of developing a cybersecurity communications strategy; and,
- Have meaningful discussions with benefit plan service providers regarding the protection of sensitive and/or critical data.

Session 3: Update on IRS Forms 1094 & 1095 & New W-4 Form:

Speaker: Karen Sanchez, Partner-in-Charge Employee Benefits, Sikich LLP

This session will review the Affordable Care Act (ACA) filing requirements for 2018 and the new IRS W-4 Forms.

- Learn about the various codes and who needs to file;
- Overview on the new IRS W-4 form; and,
- Gain knowledge of the updates to the filing process for 2018.

Session 4: IRS Update: Fringe Benefits

This session will provide information on fringe benefits, employee reimbursements, employer-provided transportation, and 1099 filling requirements. The information provided will assist in determining when taxable benefits are provided. It may also serve as a refresher on the information return filing requirements.

- Understand fringe benefits;
- Learn about accountable plans and nonaccountable plans; and,
- Review the information return filing requirements.

Session 5: Internal Controls & Fraud

The internal controls around the payroll cycle should achieve effective and efficient operations and reliable financial reporting. This session will examine some of the internal controls governments should have in place around the payroll cycle and apply those to examples of payroll-related frauds that could have been caught through proper controls.

- Understand best practice internal controls around payroll;
- Learn how additional controls, in both small and large payroll departments, can be implemented; and,
- Discuss examples of common payroll-related fraud activity and how risks can be mitigated.
