Lori A. Beeler, CPA, CGMS, Director for the Grant Accountability and Transparency Unit, Illinois Governor's Office of Management and Budget

Lori Beeler is the Director for the Grant Accountability and Transparency Unit (GATU) within the Governor's Office of Management and Budget (GOMB). Under the Grant Accountability and Transparency Act (GATA), GATU is responsible for designing and implementing Illinois' frameworks and systems to implement Federal Uniform Guidance.

Lori has been a part of GATA since its inception. She was an original member of the Illinois Single Audit Commission that drafted the GATA legislation. Prior to joining GATU in 2016, she served on several GATA subcommittees and workgroups developing GATA rules for the State of Illinois and designing associated frameworks. Lori brought a wealth of grant experience into her role with GATA. Prior to joining GATU, she was responsible for coordination of all external audits for the Illinois Department of Transportation, oversight and management of subrecipient single audit reports and implementation of GATA processes for DOT.

Michelle Binns, Senior Managing Consultant, PFM Asset Management

Michelle Binns joined PFM Asset Management in 2006 and is a senior managing consultant staffed in the Chicago office. In her current capacity, she works closely with a variety of local government clients in Illinois to develop and implement prudent investment strategies for short, intermediate, and long-term funds, including fixed income and multi-asset class portfolios. Her responsibilities include investment performance analysis, cash flow modeling, portfolio structuring and restructuring, providing economic summaries and research, and evaluating investment policies and practices for compliance with state and local investment statutes.

Michelle is the Chair of IGFOA's Partners Forum and a member of the IGFOA Executive Board.

Brad Cole, Executive Director, Illinois Municipal League (IML)

Brad serves as executive director of the Illinois Municipal League, which is the statewide association of 1,298 cities, villages, and towns. The League's mission is to articulate, defend, maintain, and promote the interests and concerns of Illinois communities. Previously, Brad was Senior Vice President of Pepsi MidAmerica, a privately-owned soft drink bottling and distribution business servicing a five-state franchise territory. His duties involved supervision of all aspects of the company, including finance, administration, human resources, fleet management, equipment services, and sales. Prior to entering the private sector, he worked as Downstate Director for U.S. Senator Mark Kirk, of Illinois. In that position, he was a key member of the senator's senior management team and was responsible for strategies initiative, outreach and constituent services in 95 (of 102) counties of Illinois. Cole served as Mayor of the City of Carbondale, Illinois for two four-year terms, which followed one four-year term on the City Council.

Before entering local government service, Brad was Deputy Chief of Staff to Illinois Governor George H. Ryan. He directly advised the Governor and coordinated the administration of government services relative to the southern 40 counties of Illinois. Active as a leader for numerous public and private organizations, he has served on a library board, a park district board, a school board, a regional healthcare system board, a multi-state economic development commission, and in many other similar posts. He has been appointed to commissions by four of the past five Governments of Illinois and was nominated to national board appointment by President George W. Bush. He is Chairman Emeritus of Sister Cities International (a citizen diplomacy organization based in Washington, DC), having served two years as chairman of its global board of directors. Brad Cole is a graduate of Southern Illinois University at Carbondale with a bachelor's degree in a double major of Political Science and Biological Science, and a Master of Legal Studies degree from the SIU School of Law. He originally hails from Macon Illinois.

David Cook, Executive Director, IPBC

Mr. Cook has served as the first Executive Director of the Intergovernmental Personnel Benefit Cooperative (IPBC) since July 2013. Previously Mr. Cook worked in local government throughout Illinois for 29 years and retired as the Village Manager of Hinsdale in 2013. Mr. Cook has a BS in Accounting from Eastern IL University. Mr. Cook has previously

served as Chairman of the Illinois Metropolitan Investment Fund and President of the Illinois Government Finance Officers Association.

During her tenure in Woodridge, Ms. Rush was responsible for an approximate \$44.5 million budget and 126 full-time employees.

In Riverside, Illinois, Ms. Rush served as the Village Manager from 1998 to 2009. As a national historic landmark, Riverside is a unique, small town with a high demand for resident service and attention to historic preservation. Designed by Frederick Law Olmsted, designer of Central Park, NY, the Village of Riverside presented a unique set of challenges and projects. The community is known for its significant amount of open space, distinctive zoning and curvilinear streets.

Prior to serving in the Manager's role in Riverside, Ms. Rush did serve as the Assistant Village Administrator in Woodridge. She served as the acting Director of Public Works for a time during which she served as the project manager during the construction of a new Village Hall.
