Citizens Response to Active Shooter/Violent Incidents Events

Recent national tragedies remind us that the risk is real; an active shooter incident can happen in any place at any time. Mass shootings start and end very quickly; first responders often cannot get to a scene in time. Sixty-three percent of active shooter events are concluded by the 15-minute mark, either by police action or by suspect suicide. The best ways to make sure you and your loved ones stay safe are to prepare ahead of time and be ready. Taking a few steps now and mentally rehearsing what to do can help you react quickly when every second counts.

- Discuss statistics as they relate to active shooter events as well as other incidents that are causing mass casualties;
- Understand why advance preparation is essential;
- Develop a survival mindset; and
