The Gift Ban Act, IGFOA members, & the Annual Conference

With the 2019 IGFOA Annual Conference approaching in September, the Executive Board wishes to remind all members of the restrictions placed on both private and public sector IGFOA members by the Illinois Gift Ban Act (Gift Ban Act) on the giving and receiving of gifts. This article is meant to be a resource for IGFOA members and is not intended to be an official interpretation or replace the opinions/interpretations of legal counsel on the Gift Ban Act statute.

Gift Ban Act Refresher

Effective December 9, 2003, as part of the *Illinois State Officials and Employees Ethics Act*, the Gift Ban Act prohibits state officers, employees, and General Assembly members from receiving gifts from prohibited sources exceeding certain dollar amounts. The Gift Ban Act also forbids prohibited sources from giving gifts exceeding certain dollar limitations.

The Gift Ban Act excludes units of local governments, their officers, and school districts. However, effective May 9, 2004, the Act required all local governmental entities to adopt an ordinance or a resolution that is no less restrictive than the Gift Ban Act applicable at the State level.

The Gift Ban Act permits gifts of food or refreshments so long as it does not exceed \$75 per person on a single calendar day. The food or refreshment must be either catered or consumed on the premises from which they were purchased or prepared. The Gift Ban Act permits gifts from any one prohibited source during any calendar year having a cumulative value of less than \$100. These allowances are mutually exclusive and independent of each other.

What does this mean for IGFOA Public Sector members?

Every public sector member employed by a unit of local government is subject to the Gift Ban Act via adoption of a local ordinance or resolution. Public sector members should review the specific provisions adopted in their local ordinance or resolution. Seek assistance or clarification from your government's legal counsel if the requirements are unclear. Your local ordinance may be more restrictive than the State prohibitions. Every IGFOA public sector member is responsible for under-

standing the restrictions defined by their local ordinance and for determining if an offer from a prohibited source violates their ethics ordinance. Accordingly, the statute is enforced through self-monitoring.

What does this mean for IGFOA Partners and Exhibitors?

IGFOA Partners and Exhibitors in the Vendor Showcase at the Annual Conference should be aware that all public sector members are subject to the Gift Ban Act, and that some public sector members must comply with local ordinances more restrictive than the minimum State required prohibitions. In some cases, those ordinances have a zero-tolerance on gifts where any offer of a gift must be declined.

Partners should also be aware that if they are considered to be a "prohibited source" they are subject to the Gift Ban Act and may be in violation of the Act by offering gifts exceeding the State minimum restrictions.

How does IGFOA support its members with complying with the Gift Ban Act?

In the Vendor Showcase at the Annual Conference, Exhibitors are strictly prohibited from raffling prizes. Exhibitors may offer gifts of nominal value, such as pens or candy.

- ► IGFOA does not accept donations from Partners or Exhibitors for gifts or prizes to public sector members.
- ► IGFOA allows participants to "opt-in" to raffles rather than automatically including all registrants in the drawing.
- ► IGFOA does not accept third party payments for any IGFOA state-wide or Chapter event (i.e., a partner may not pay for a public sector member's golf outing fee).

After a nationwide search, the College of DuPage has selected IGFOA member/volunteer and GASB Board member Dr. Brian Caputo, CPA, CPFO, to serve as College Piresident.

"Dr. Caputo brings with him a wealth of experience and leadership qualities that will serve College of DuPage well. He possesses a clear understanding of where higher education is heading and values collaboration with both faculty and staff," said Board Chairman Frank Napolitano.

Since joining College of DuPage as Vice President for Administrative Affairs and CFO, Brian has been instrumental in helping to strengthen key institutional initiatives in partnership with the Board, administration, faculty, staff and students. Under his leadership, the College's general obligation bond rating improved from AA to AA+ with Standard & Poor's Global Ratings, and Moody's Investors Service affirmed the College's Aa1 rating as well as shifted its outlook from stable to positive.

Brian earned a Bachelor of Science from the U.S. Military Academy at West Point, a Master of Science in Accountancy from DePaul University, and a Master of Public Administration from NIU. He also earned a Ph.D. from NIU with public administration, public policy and government finance as fields of study. He served as a full-time faculty member at Central Michigan University and as an adjunct faculty member at Northern Illinois University (NIU). Prior to becoming a vice president at College of DuPage in March 2017, he served as Chief Financial Officer/City Treasurer of the City of Aurora for nearly 19 years.

Brian is a long-time volunteer for IGFOA, beginning in the mid-1990s when he was recruited for the Technical Accounting and Review Committee (TARC). He became Chair of TARC, eventually leaving the Committee to join the Executive Board. Brian served as IGFOA President in 2004 and continues to serve as an instructor for various seminars/ webinars and the speaker for the GAAP Update at the IGFOA Annual Conference.

With the restructuring of the IGFOA Partner Program in 2014, Chapter support monies are collected as part of overall State Association dues and distributed to Chapters based on a formula that considers Partner dues collected in the current year and Chapter membership and event data in the prior calendar year. This eliminates separate sponsorships and contributions from Partners.

Chapters then use the funds for the benefit of their Chapter members, such as registration fee scholarships for the IGFOA Annual Conference and subsidizing Chapter events, such as the Downstate Conference and the Chicago Metro and South Metro Holiday events.

In addition, Chapters are once again contributing their resources to sponsor the IGFOA Annual Conference Monday Keynote Speaker, Jason Kuhn.
